#### Streets

# BEDAB Update from Ben Hemson Wednesday's Council Meeting

State Economist, Josh Lehner, was on hand during Wednesday's work session with Council to provide a brief economic outlook. The discussion centered on state-level wage and job growth, notably Oregon's median income now sits at an all-time high and exceeds the national average for the first time since the early 1980s. #### **COAR Quarterly Market Report**

You may have caught the news earlier this week that Bend's median home sale price hit \$470,000 last month (!). If you'd like to get more into the data, the Central Oregon Association of Realtor's just rolled out their quarterly market report, which they create in partnership with ECONorthwest. Here's a snapshot of their look at the Bend market:

**Bend** - Home sales are up almost 70% from the first quarter of the year, and almost on par with home sales volume for the same quarter last year. Home sale prices have increased more than 8% over the past year.

# **Utility Department's Christina Davenport Earns Statewide Honor**

The City of Bend Utility Department's Industrial Pretreatment Program Manager, Christina Davenport, recently took home the 2019 Outstanding Individual award from the statewide Oregon Association of Clean Water Agencies (ACWA) for her leadership and innovation in protecting Oregon's water quality. The Oregon Association of Clean Water Agencies annually presents awards for outstanding achievement within the ranks of its members. The annual awards are given to an **Outstanding Individual** and **Outstanding Member Agency** excelling in any of the areas of pollution prevention, environmental leadership, or innovation in environmental management. Christina was recognized by ACWA's Board President, Amy Pepper, who remarked, "A true asset to our community, Christina strives to protect the environment and public health, building relationships and collaborating to find innovative solutions for a sustainable future." # ACWA President Amy Pepper Full Remarks in Recognizing Bend Utility Department's Christina Davenport for the 2019 Outstanding Individual Award

Christina is the Industrial Pretreatment Program Manager for the City of Bend and she has been an active participant in the ACWA Pretreatment Committee for five years.

Christina's work with the City of Bend has been impressive. The City of Bend industrial pretreatment program regulates metal finishers, semi-conductor manufacturers, pharmaceutical manufacturing, and pheromone based pesticide manufacturing. Some of these industries and technologies are unique to Bend and fall outside of the current federal guidelines, which require multiple discussions with DEQ and EPA to determine just exactly how to regulate them.

Some of Christina's notable accomplishments include the following. She was instrumental in the construction of a membrane bioreactor at a large scale pharmaceutical manufacturing company, reducing solvent and pharmaceutical waste entering the water reclamation facility.

Christina has been influential and a leader in brewery sustainability and succeeded in working with the industry to side stream a majority of the Bend's breweries high strength waste, keeping it out of the City of Bend POTW. The City of Bend has over 20 breweries, 3 cider producers, 3 distilleries and 4 kombucha makers.

She has developed a statewide and national reputation for her expertise, and is called on regularly for consultant consultation and advice. She understands the complexities of brewery waste and is passionate about unique solutions that reduce wastewater and are beneficial to recover and reuse the waste products. She is often quoted as saying "These are resources not waste products. We need to find ways to utilize them in our community and nationally."

Christina has been an active participant in the ACWA pretreatment committee and has hosted the ACWA monthly meeting here in Bend in June annually. She has assisted with the ACWA conference in Bend every July. She is also a chair of the PNCWA (Pacific Northwest Clean Water Association) Resource and Recovery committee.

On a final note, Christina often teaches yoga to the cops on her lunch break and also initiated a wellness program with the City of Bend Police department, which has received national recognition, including an award from the Justice Department.
