Bend Police Department

Bend PD is featured in an article on the nationally syndicated police forum PoliceOne.com., <u>12 Police Recruitment Ideas Every Agency Should Consider</u>. The article features the recruiting video, other department's efforts around the State and discusses many ideas and principles the BPD has developed. This article was prompted by two different presentations Chief Porter made at the International Association of Chief of Police conference on Wellness and on the Recruiting and Hiring Program.

Bend PD is recognized as a progressive agency that places its people and their families first. In the email sent Chief Porter states, "By most standards we are not a large department, but we have made a huge impact on a national scale in the direction our profession has taken in dealing with officers stress, wellness, and the inclusion of families into law enforcement agencies."

Warming Shelter Update

On October 29th a large group gathered to discuss potential options with the Homeless Leadership Coalition (HLC) who is taking the lead on identifying and supporting a Bend area warming shelter. The City of Bend was well represented with Councilors Abernethy, Campbell, and Livingston present as well as Colin Stephens, Larry Medina, Jaime Gomez-Beltran, and Shelly Smith. Attached is the initial invite letter that outlines the need for the warming shelter as well as existing resources.

Many options were discussed at the meeting, several churches have stated that they are trying to see how they can provide part of the solution for smaller numbers and real estate representatives are looking for potential vacant buildings that meet the recommended standards for the warming shelter. Shepard's House and Bethlehem Inn are at capacity each night and yet were at the table to discuss all available options.

At this point no specific shelter has been identified and the need continues to be critical. The HLC is continuing efforts to facilitate this important need. BEDAB Update from Ben Hemson Chapter 4.7 of the Development Code

On Monday, the BEDAB's Advocacy Subcommittee discussed proposed changes to Chapter 4.7 of the Bend Development Code, relating to the trip threshold for traffic studies for new development. After some good review and questions from the subcommittee, the group developed some key points involving their support for the change.

Planning Commission heard a short overview of the proposal during their work session on Monday evening and had few questions or input on the proposal.

This is a complex topic, so we'll discuss it in more detail again at BEDAB's November meeting on Monday. You can find that agenda here. BEDAB will then have the option to share their feedback with the Planning Commission directly at their public hearing on November 25th or with Council once they take up the discussion (or both).

A week of Forecast Breakfasts

Letter to Bend area public and private officials regarding 2019-2020 Emergency warming shelter needs

Status: Urgent

Winter temperatures are already upon us here in Central Oregon. The Homeless Leadership Coalition (HLC) is working with our network of emergency and permanent shelters and service providers to ensure we have the capacity we need to keep individuals experiencing homelessness warm at night, and save lives.

Specifically, the need for low barrier shelters for a cross section of adults and youth in our community is going to be the biggest gap for this coming season due to the following factors:

• Currently Shepherd's House Ministries is the only ongoing program in Bend that provides low barrier shelter services for adults during the winter season. This past winter, they absorbed 40+ additional male adults into their regular shelter program during the most severe weeks of winter. This well exceeded their permitted capacity and unfortunately re-traumatized the 30 men in their long-term recovery program, requiring months of post-winter stabilization.

Even though their decision most likely saved human lives, their board of directors has decided this level of accommodation can no longer be provided due to safety and risk management concerns and their commitment to adhere to trauma-informed care principles.

- With Bethlehem Inn's new increased capacity (150 per night), the Inn will continue to work to support a low barrier shelter in Bend as well as do full in-takes for those who can meet program (high barrier) requirements; the Inn has limited capacity for only two low barrier /warming shelter beds per night. Bethlehem Inn is filling an extreme need in our community and does not have the capacity to take on additional individuals to the level our community requires
- This past winter, Sagewood Sanctuary also extended a strong commitment to our region by taking in approximately 50+ adults into a low barrier program in temporary space made available by a very concerned group of individuals. Due to a variety of operational and community concerns being experienced by this program, they will no longer be able to operate this year, even though their extension of compassion and service this past winter most likely also saved human lives.
- Due to the above realities, the Homeless Leadership Coalition estimates that we will need up to 100 additional low barrier, adult shelter beds, to meet just the present needs in our Bend community.
 Additionally, smaller cold weather shelter providers are facing similar challenges across the region.

As a partner with Oregon Housing and Community Services our goal is to meet the needs of the most vulnerable in our community this winter season and we know that collaboration and full transparency with all community leaders and stakeholders is the best approach to take.

More specifically, we are asking for the following:

- We would like to see a central building made available in Bend to address this vulnerable population of individuals experiencing homelessness in our region, during the most severe weeks of our winter.
- We request assistance in identifying possible funding sources that will be able to adequately provide the necessary level of trained staff and volunteers to ensure safety, adherence to low-barrier homeless program standards, and a service that will be received well by all members of the bend community.
- We need assistance and coordination in getting necessary and accurate media attention that this initiative will require in order to ensure the safety of the most vulnerable in our community this winter season.
- Your attendance at a meeting to be held on October 29th to further discuss the above issues and requests, the role your agency is willing to play and how we can best coordinate our combined efforts.
