#### **BEDAB Upcoming Meetings**

## **Planning Commission Work Session on Core Area**

On Monday, Keith Dodge and Brecht Palombo represented the BEDAB during a Planning Commission work session discussing proposed changes to development code within the Core Area. These changes are largely a response to the lack of development, despite interest, in the area often referred to as the Bend Central District.

The two areas that generated the most discussion were a relaxation in parking requirements and an increase of removal of the current cap of 30,000 square feet for a single use (you can view a brief memo on the amendments here). While changes to parking standards are a common cause for concern in the community, a number of committee members expressed support for the proposal based on the potential to spur development with any potential parking concerns actually showing up years or decades down the road. City staff and a consultant team prepared a parking analysis that provides more detail on the topic, you can read it here.

The Planning Commission will take up the discussion again in mid-January with Council expected to make a decision on the proposal in early February. You can expect this to be a topic at the BEDAB meeting on January 6<sup>th</sup> as well as the Advocacy Subcommittee in December.

### **County-by-County GDP**

Yesterday the US Bureau of Economic Analysis rolled out their County-by-County breakdown of Gross Domestic Product for 2018. This is a little later than usual but there were a number of interesting takeaways on Deschutes County's economic trajectory. The Deschutes County Economy approached \$8.2 billion in GDP in 2018 (using 2012 dollars), an increase of 3.6% over 2017. An annual growth rate of 3.6% would be a welcome sign for most counties; however, the prior two years Deschutes County's growth rate hovered between seven and nine percent. This helps illustrate the point we've heard from folks like Damon Runberg: Central Oregon has roared back from the Great Recession and is likely shifting into a more stable long-term economic pattern. Of course, a recession could upend our region's growth potential, <u>here's a quick read from The New York Times</u> yesterday that breaks down some of the key indicators for recession and what to watch for.

# Mid-Oregon Credit Union Workforce Housing Program

We talk a lot about housing supply during BEDAB meetings, here's how one member, Kevin Cole, has been involved in private sector efforts to spur affordable rental development. Earlier this week Mid-Oregon Credit Union rolled out a program offering interest rate subsidies up to 2.5% for new rental properties that will maintain affordable rents for their first five years. KTVZ has an article and brief video on the program here.

#### From the KTVZ article:

To qualify, rental rates could not exceed 30% of gross income for tenants earning between 60%-140% of Area Median Income (AMI). Current AMI in Deschutes County currently stands at \$55,700 for a family of four. The program also offers a fixed interest rate for five years.

#### **Farewell to Kip Barrett**
