Why Has This Measure Been Referred to the Ballot?

In the May 2023 election, voters will have the opportunity to consider a five-year local option levy which would provide funding for fire and emergency medical services. If the measure passes, it would cost property owners \$0.76 per \$1000 of assessed property value.





What is a local option levy?



Proposed 5-Year Local Option Levy

- Also known as an operating levy.
- A levy is a funding option is placed on the ballot for voter consideration.
- It is a tax with a rate that is determined by a property owner's <u>taxable assessed</u> value of their structures and land.
- Levies can last for up to five years before expiration, after which a new levy can be submitted to voters for consideration.
- If the measure passes, Bend Fire &
 Rescue would use the levy funding to
 support staffing and expenses related to
 staffing such as equipment and training.





Existing Levy Funding

- In 2014, Bend area voters passed a levy of \$0.20 per \$1,000 of taxable assessed property value.
- Voters passed the current levy in 2018 at the same rate.
- The current levy expires in June 2024.






Why is a new levy being proposed to voters?




Growing Call Volume


- More people coming to Bend means more calls for Bend Fire & Rescue.
- Since 2014, Bend Fire & Rescue's call volume has grown over 60% and is expected to increase another 38% by 2029.





Increasing Response Times






- A growing call volume makes it more likely that there will be multiple calls at once.
- When resources are tied up on one call, it may take longer for crews to respond from another station across town.
- Quick response times correlate to better patient outcomes for medical calls, and more lives and property saved for fire calls.



Rising Costs

- Looking forward from today through 2029, costs are outpacing the increase in funding:
 - Annual operating cost increase 5%
 - Annual operating revenue increase 4%
- 81% of funding is from property taxes, which are based on taxable assessed value.






Real Market vs Taxable Assessed Value



- Taxable assessed value is the amount that the local tax authority estimated for a property owner's structures and land.
- In Oregon, this amount is typically much lower than market value due to a cap on property tax that was put in place by <u>State Measures 5 and 50.</u>
- Bend has the lowest property tax rates in the state.
- Real market value has been increasing, but total assessed value growth is limited by Measures 5 and 50.

Structural Financial Challenges

Property Taxes for Fire Districts in Deschutes County





Bend's tax rate per \$1,000 of assessed value is the lowest of all fire departments/districts in Deschutes County. The amount of taxes paid each year based on the # of tax accounts in each district ranges from \$269 to \$1,709. Bend property owners pay an average of \$432 for fire and EMS services.

If the measure passes, what would the levy cost taxpayers?



Cost to the Average Property Owner



The proposed levy would cost taxpayers \$0.76 per \$1,000 taxable assessed value for five years.



If the measure passes, this would be a 56-cent increase from the current levy, which expires in June 2024.



The average cost for property owners in the City and Rural District would be about \$19 per month. This estimate is based on a property with a taxable assessed value of \$300,000, which is the City's average.



If passed, what would the levy fund?



Retain Current Staffing Levels


- If passed, \$0.70 of the \$0.76 proposed levy would retain current staffing levels for Bend Fire & Rescue.
- This would include 10 positions that are funded by temporary funding nine firefighter/paramedics and one business manager.
- If passed, the new measure would replace the current levy funding and the one-time infusion of American Rescue Plan Act (ARPA) funds, both of which expire in June 2024.





Support Staffing Demands Through 2029

- If passed, \$0.06 of the \$0.76 proposed levy would be used to support the hiring of 10 more positions for Bend Fire & Rescue.
- This would include six firefighter/paramedics, three emergency medical technicians and one ambulance biller.





Purchase Equipment & Provide Training

- If passed, the proposed measure would support continuing education and maintain essential fire and emergency medical care training for Bend Fire & Rescue first responders.
- The measure would also fund the purchase and maintenance of materials and equipment like medical supplies, fuel, personal protective equipment and vehicles.






Service Area and Services Provided

Bend Fire & Rescue serves 1,450 lane miles in Bend and the surrounding Rural community.


Services provided by Bend Fire & Rescue include:

- structural and wildland fires
- medical emergencies and motor vehicle accidents
- special rescue operations including swift water and rope rescue
- fire prevention services including fire investigations, fire mitigation inspections, smoke detector installations, and wildfire risk mitigation

Service Levels at Current Staffing

- Staffing Pilot Butte Station
- Cardiac resuscitation rates
- Tiered EMS response system
- Service Response Vehicle program
- Emergency response time targets
 - 6 minutes in the City
 - 9 minutes in the Rural District
- Call volume growth and increased unit hour utilization






If passed, the levy would fund...



- Full staffing through June 2029.
- Increasing the 12-hour Basic Life Support ambulance program to 24 hours.
- Adding an ambulance biller to keep pace with the added volume of billing.



If the measure does not pass...



- Bend Fire & Rescue would propose a levy on up to two consecutive ballots.
- Staffing and services would not be provided as proposed and property taxes would not increase.
