Joseph Walsh introduced himself and said he was interested in getting involved with RWNA. His main interests are street safety and transportation safety, especially on the Galveston and Newport Corridors. He is also interested in Greenways throughout Bend.

Elisa Cheng introduced herself and is willing to donate time in April to update the RWNA web site. She recommends transferring the site from Weebly to Wordpress.

Reports

- NLA NLA report was emailed earlier. There was discussion on temporary housing and HB2001. Temporary housing will be split into 2 code updates. Homeless camps plans are still being worked on and the city will have a sounding board regarding the camps. Discussion was had on whether RWNA will contribute to COB outreach mailer for NA's and NLA.
- Treasurer's Report \$2,147.58 was spent on the Virtual Annual meeting postcard. RWNA has \$9,930.55 remaining in there 20-21 budget.
- Transportation and Parking Gina is getting up to speed on Transportation and Parking as the RWNA
 representative. She has contacted COB regarding the Newport Corridor for answers to RWNA concerns
 and questions about the project. She has not received any responses. Gena, RWNA Council rep
 volunteered to help if Gina doesn't get responses.
 - With the McKay Parking District becoming permanent RWNA has their first parking permit program in the NA.
 - A COB council member suggested that eliminating or reducing off street parking for all should be considered. There would be no off-street parking minimums in Bend. Several NA's have composed a parking survey to send out. Discussion was had on RWNA sending out the survey.
- Parks and Rec Susan attended the Bend Park and Rec board meeting virtually on 2/16/20. Susan emailed a report to the board prior. Some of the highlights are: Trail usage is up 23%. Park and Rec are working on a comprehensive plan. They are looking at acreage needed for neighborhood parks and a walking analysis.
 - Park and Recreation is also doing a Deschutes River Access and Habitat Restoration project. They are looking at river access with in the COB and proposing elimination and addition of access sites. Since RWNA has several parks with river access, neighbors and RWNA members may be affected by the changes.

The was a motion made for approval of a fee not to exceed \$500 to redesign and update the RWNA web site and an ongoing yearly fee not to exceed \$300 for the website hosting and domain. The motion passed unanimously.
