When you open Eplans the 15 most recent you see are the ones that others have recently viewed. It is not the most recent filed land use applications.

The Land Use application are files chronologically with the oldest first.

- -If you don't have the PZ number and want to see the latest filed land use applications
- -Click on All Projects tab
- -Click on the last page arrow at lower left of page
- -Click on the page back arrow until you start to see PZ -18-xxxx.

There are a few pages of old PZ and revoked applications prior to seeing the PZ-18 numbers.
