- e. Galveston Roundabout meeting Oct 18th from 4 to 6pm in the city council room.
 - Deb and Cassie gave some background on the last time a roundabout was considered when culminated in the City Council voting against including a mini-roundabout.

- Deb gave an insight to the current opinion of many in the neighborhood which are nearly all opposing the mini-roundabout.
- Deb believes the city staff is behind this latest effort to include the mini-roundabout which includes one-way streets and angled parking. There is a concern the additional parking is a ploy to facilitate more development along Galveston without providing sufficient off-street parking.
- There was concern expressed that the staff presentation on the 18th will be an attempt to have staff lecture the audience on why staff knows best instead of really listening to the audience.
- Staff is pressing forward with a schedule to reach a decision from Council to enable the design to be wrapped up.
- There was concern that Councilor Russell should excuse herself from any decisions due to her ownership of property in this area.
- Frustration was expressed that the city is focusing on completing a plan that the neighborhood doesn't want and the city has no funding for.
 Meanwhile, steps could be taken now to improve safety without waiting for the ultimate plan to be designed and funded.
- The board agreed that the RWNA needs to communicate directly with the Council on the results of this upcoming meeting on the 18th and not leave it up to staff to report their version of the outcome.
- f. STR Compliance Hotline and Website -

[Future task: Concern has been raised that the process adopted by the city has not always been followed and compliance with conditions not enforced. A work group may be needed to research whether this matter needs to be considered again by the council. If evidence exists that the process is flawed or not being followed, the NLA may be the best avenue to communicate the findings to the Council.}
