Sharon Wojda - Budget & Financial Planning Manager

- Main revenue sources for General Fund are from property taxes (but not city-wide)
- · City has held financial strategy sessions on budget cuts
- Expenditures can only cut programs, not services
 - Funds reserved for police, fire department, streets, transit, and long range planning.
- Community Development services reduced work force by 44%.
 - 18% were removed from one specific function (planning or building). Overall, between layoffs and not filling vacancies, that staff has reduced staff by 44%.
- · Stormwater fees are only for storm utilities, with restricted spending uses, by law
- Juniper Ridge has separate fund from other sources, and a line of credit through banks
- During hard times, people get creative with saving money

Hardy Hanson - Streets/ Stormwater Division Manager

- Backflow testing devices mandatory testing is for water safety, required by federal law, not for fee collection
- · Public Works services effects quality of life for Bend residents
 - · Water, sewer, traffic, sidewalks, etc.
 - 8 departments altogether, including engineering, water quality testing, public transit, streets division, stormwater, transportation engineering, water division, water reclamation (sewer)
 - Street sweeping may have future cuts (effects cleanliness, water quality, bikelanes)
 - Roads consist of 800 miles in-city, including painting, crosswalks, storm drains, sweeping, sanding and snow removal
- Stormwater Master Plan review meetings occurring 1/29 and 2/05
 - Drywells design and land-use issue
- ODOT turned over Third Street underpass to City. Goal is to reroute stormwater to Colorado Bridge
- Snow Removal December '08 removal cost \$107,000
- Budget cuts options: city landscaping cut and close to elimination altogether, snow removal future cuts
- City Council looks to Public Works department first for cuts in order to keep police and fire services
- \$2.7 million needed to keep streets at current condition level (another \$1 million may need to be cut also)
- Potholes hotline 317-3000

Brian Shetterly - Long Range Planning manager

- Planning division reviews site plan applications for development code conformance
- · Building division includes inspections, building plans examiners and code review
- Every Oregon city has to follow code adopts by state and development codes
- Between 2006-2008, 6,000 people added to Bend's population, and is still growing despite the economic downturn
- Community Development is funded by permits fees for building planning fees and general fund (with subsidies)

- Budget \$7 million total for planning and development
- Since 2007 lay offs include more than 50% of employees and possibly more
- Materials and services budget reduced 75%, no overtime, no new hires
- Building permits are down 20%, planning is down 30%
- Long Range Planning not slow, due to Urban Growth Boundary expansion for 20year growth (mandated by the state)
