Parks & Rec Chair Report:

- Property tax collection: the fiscal year budget (adopted June 3) and tax revenues are very conservative, however tax collections suggest that no budget cuts are needed at this time.
- Review of Pyramid Pricing philosophy: designed to require cost recovery from fees the higher on the pyramid a program is (based upon individual benefits compared with
 community benefits). Data suggests individual programs are recovering a lower %
 than some lower level programs. Fee adjustments may be transitioned in.
- JSFC update; Warrantee repair work for floors & shower room repair complete.
- JSFC parking lot expansion: additional funds requested for additional work.
- Resolution 2009: Recreation Trails Program Grant requests authorization for applying for RTP Grant for Pioneer Park to Revere Avenue Deschutes River Trail, which is within RWNA boundaries (with a 20% match from the District).
- Dog Park Plan: collected citizen reactions to the proposal, via public meetings and individual contacts. Results will be compiled and reported in January.
